Terms Governing Access to www.mileleprime.com

1. Acceptance

These Website Terms of Use (the "Terms") govern access to and use of www.mileleprime.com and its subdomains, content, tools and applications (the "Website"), operated by Milele Prime Ltd (the "Company"). By accessing the Website you agree to these Terms, the Privacy Policy and the Cookie Policy. If you do not agree, do not use the Website. Trading services are governed separately by the Client Agreement and its associated documents, which prevail over these Terms in respect of trading.

2. Informational Purposes Only; No Offer or Advice

Website content, including market data, quotes, charts, calculators, calendars, sentiment tools, articles, videos and blog posts, is provided for general information only. It does not constitute investment, financial, legal or tax advice, a personal recommendation, or an offer or solicitation to buy or sell any instrument, and it is not directed at any person in a jurisdiction where its publication or availability would be unlawful.
